ADDENDUM TO MEMORANDUM OF UNDERSTANDING Electronics-ICT

Between on the one side

Thomas More Mechelen-Antwerpen vzw, Belgium and Thomas More Kempen vzw, Belgium ('Thomas More University College')

And on the other side

Zaporizhzhya National Technical University, Ukraine

('Partner')

Hereinafter collectively referred to as "Parties" or individually referred to as "Party",

WHEREAS

- The Parties have entered into a Memorandum of Understanding to establish a stable framework for collaboration in teaching and research areas;

- The Parties in this addendum want to lay down their specific commitments concerning Thomas More's University College Electronics-ICT study programme and Partners' Zaporizhzhya National Technical University Software Tools Department study programme.

Now, THEREFORE, the Parties hereby agree as follows;

1. General

- 1.1. Parties agree to perform their tasks pursuant to this addendum with accuracy and to the best of their ability.
- 1.2. Commitments in this addendum only cover Thomas More's University College Electronics-ICT study programme and Partners' Zaporizhzhya National Technical University Software Tools Department study programme. Commitments concerning other study programmes are agreed upon in separate addenda.

2. Exchange Conditions students

- 2.1. A maximum of 2 students, enrolled in Partner, may attend Thomas More's University College each year (bachelor/undergraduate degree) for the duration of one year. In exchange, 2 students from Thomas More More's University College may attend Partner for a duration of one year (bachelor/undergraduate degree).
- 2.2. Participating students will be selected by their home Party on the basis of the following criteria:
 - a. The students selected, should have completed at least one year full-time study at the home Party;
 - b. They should have an excellent academic record;
 - c.They should meet all admission or specific requirements of the home Party and host Party.

- 2.3. The host Party shall provide the students appropriate assistance for registration, campus life and local customs.
- 2.4. The host Party shall provide the students with the necessary documents and information about visas in accordance with current laws, although it is the responsibility of the individual student to obtain a visa in a timely manner.
- 2.5. At the end of the exchange program, the host Party sends the home Party an official transcript of credits obtained by the students.
- 2.6. Each Party reserves the right to dismiss any participating student at any time for academic or personal misconduct in violation of established regulations of the host Party. The dismissal of a student shall not abrogate the addendum for the arrangements regarding other participants.

3. Exchange conditions teachers

3.1. A maximum of 2 teachers, working at Partner, may teach at Thomas More's University College each year. In exchange, 2 teachers from Thomas More University College may teach at Partner.

4. Financial

- 4.1. Participating students shall enrol at their home Party and they shall be exempted from paying tuition, application, and academic fees to the host Party.
- 4.2. The Parties agree that for student exchange, the host Party shall make every reasonable effort to arrange for the students a suitable accommodation. The students will pay for this accommodation themselves.

5. Duration

- 5.1. This addendum becomes effective from the day the representatives of the Parties affix their signatures below.
- 5.2. This addendum may be amended by written consent of the Parties.
- 5.3. The duration of this addendum is based on Memorandum of Understanding that was signed by both Parties. However this addendum may be terminated by either Party upon giving six months written notice.
